



# **Dock & Access Locations**

## **IMPORTANT NOTICE:**

The use of ALA accesses and trail system is limited to members of the Arrowhead Lake Association and/or property owners of Arrowhead Woods. Proof of membership or property ownership will be required. Failure to provide such proof upon demand may result in denial of access or right of use of ALA property.

#### PLEASE NOTE:

Street level entrances to accesses are adjacent to private property in most cases. Shoreline level entrances to accesses are adjacent to members' docks in many cases. Please respect the individual owners' private property as you travel up and down the ALA dock access stairways and paths and along the shoreline trails. Thank you.

### PARKING CAUTION:

While parking your vehicle to access ALA trails or your dock, please do not park on private property, block driveways or block emergency vehicle access.
